## Request for extended supply of medicine 2024

### Purpose of the form

This is an application to ask for an extended supply of chronic or acute medicine.

We will review this request only when you need the extra supply of chronic or acute medicine because you will be traveling for longer than one month, or up to and no longer than six months. Please note: the maximum period for extended supply of medicines we will consider is six months. We will decline requests for periods longer than six months.

If you cancel your Society membership or if your membership is suspended during the period for which we have approved your extended supply of medicine, you may have to pay the costs yourself or we may need to recover the money from you.

### What you must do

- You need to apply at least seven working days before you travel.
- Complete one application form for each patient.
- Fill in the form in black ink and print clearly, or complete the form digitally.
- All relevant sections must be signed by the patient. The patient must sign and date any changes.
- If the applicant is under 18, a parent or legal guardian must complete the application form on their behalf. To avoid administration delays, please ensure this application is completed in full.

### Please note

- This is an approval for funding only and does not override any legal requirements that your pharmacist must comply with.
- You will need to have a valid prescription for the requested medicine and there are some medicines where the maximum quantity that can be dispensed is a 30 day supply.
- Please also check the Customs requirements and laws of the country you are visiting before you travel to avoid any issues with travelling with your medicine.
